



RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

For participation in North American XJ Association (NAXJA) events, the undersigned hereby agrees to release and hold harmless any owners, sponsors, trail guides, workers, and owners of both public and private land where NAXJA events are held. This shall also include officers, directors, and agents of the NAXJA. The above shall also be released from any negligent act or omission and shall include any loss damage or cost incurred due to participation in this event.

The participant shall understand and assume full responsibility and risk for any property damage, injury or death while participating in this event. In signing this release, each participant hereby agrees to the following:

- (a) That the owner/operator certifies that he/she has inspected this vehicle and that the vehicle is in good working order.
- (b) That each participant has informed himself/herself about the event and the trails involved in the event.
- (c) That he/she has read all the foregoing Releases and Waiver of Liability and Indemnity Agreement.
- (d) Participants acknowledge that trail-riding is hazardous, dangerous, and unpredictable.
- (e) Meets or exceeds the following list of required equipment.
 - 1. At least one, visibly charged fire extinguisher (Type B:C, or A:B:C)
 - 2. First Aid Kit
 - 3. Adequate spare tire, Jack, and Lug Wrench
 - 4. Safety belts for driver and any passengers
 - 5. Adequate attachment points in the front AND rear of the vehicle. Acceptable forms of attachment points are: Tow Hooks of OEM or greater integrity, D-Rings, Front and/or Rear Receivers, Shackles or Clevis.
 - 6. At least one, 20ft, 10,000 lb Snatch Strap WITHOUT metal hooks.
 - 7. A properly secured Battery
